Houston Influencer Sweepstakes
Official Rules**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED

ELIGIBILITY: Only legal residents of the Greater Houston Area, TX who are 18 years of age or older and have a valid email address are eligible to enter. Not open to employees, officers or directors (or to members of the immediate family or household of any employees, officers, or directors) of Haverty Furniture Companies, Inc. (“Sponsor”), or any of its parents, subsidiaries, affiliates, or any advertising or promotion agencies involved in this Sweepstakes promotion (collectively, the “Sweepstakes Entities”). No illegible, incomplete, forged, or other automated multiple entries will be accepted. Entry must include valid email address. By entering, you agree to these Official Rules. Email addresses will be added to our email distribution list. You may opt out at any time.

WINNER SELECTION AND NOTIFICATION: One (1) winner will be randomly selected on or about 2/7/25. The drawing will be from along all eligible entries received. The potential winner will be notified on Instagram, via direct message using the contact information given at the time of entry. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If a potential winner does not respond within 10 days after the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner may be disqualified and an alternate winner may be selected.
